MEDICARE ADVANTAGE COVID-19 AT-HOME TEST REIMBURSEMENT

Eligible Medicare Advantage members can get reimbursed up to \$12 per test for FDA-authorized, at-home COVID-19 tests. Members can request reimbursement for up to eight tests each month, for purchases made on or after January 15, 2022. Submit a separate form for each covered member.
